## 1.1 Product Features




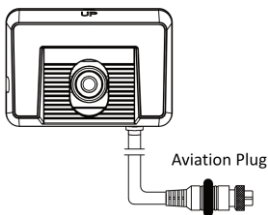


Figure 2-4 Overview

The power supply for the camera is DC 9 V to 16 V wide voltage range mobile DC. Make sure that your cable matches with the plug.

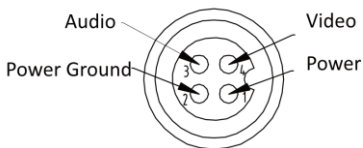


Figure 2-4 A Sequence

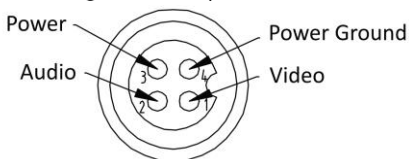


Figure 2-4 B Sequence

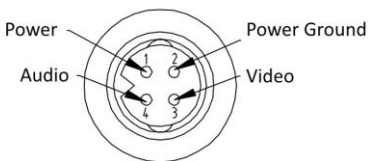


Figure 2-4 BM Sequence

## 2 Installation

---

### ***Before you start:***

- Please make sure that the device in the package is in good condition and all the assembly parts are included.
- Make sure that all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Check whether the power supply is matched with your power output to avoid damage.
- Be sure that there is enough space to install the camera and accessories.
- Make sure the part, which is used to install the camera, is strong enough to withstand four times the weight of the camera and the mounting.
- If the product does not function properly, please contact your dealer or the nearest service center. Do not disassemble the camera for repair or maintenance by yourself.

**Steps:**

1. Clean the mounting surface with a mixture of isopropyl and water.

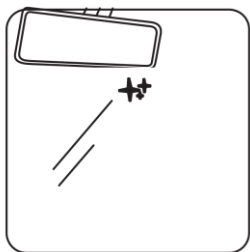


Figure 2-1 Clean the Surface

2. Tear off the release paper on the camera body. Stick the camera to the installation surface with the "UP" sign on top. Press it for 15-20 s.

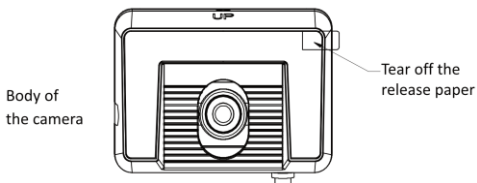


Figure 2-2 Tear Off the Release Paper

 **NOTE**

Keep the camera staying there for over 12 h to avoid the disintegration of the glue.

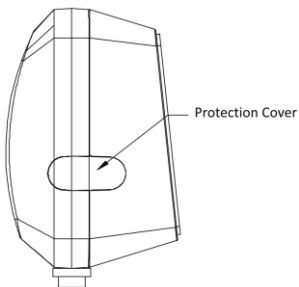


Figure 2-3 Open the Protection Cover

3. Adjust the camera to the target angle. Open the protection cover on the side of the camera, as shown in Figure 2-3.

4. Adjust the angle of the camera by adjusting the adjustment structure with a screw, then tighten the fixing screw and recover the cover of the camera

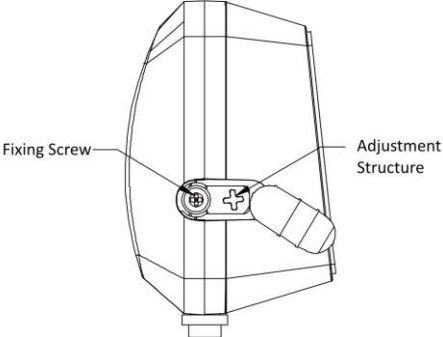


Figure 2-4 Adjust the Angle
